 "Guarantor" means that person (or persons), or entity, who agrees to be liable for the debts of the Customer on a principal debtor basis.

 "Goods" shall mean Goods supplied by the Seller to the Customer (and where the context so permits shall include any supply of Services as hereinafter defined) and are as described on the invoices, quotation, work authorisation or any other forms as provided by the Seller to the Customer.

 "Services" shall mean all Services supplied by the Seller to the Customer and includes any advice or recommendations (and where the context so permits shall include any supply of Goods as defined above).

 "Price" shall mean the price payable for the Goods as agreed between the Seller and the Customer in accordance
- with clause 4 of this contract.

The Commonwealth Trade Practices Act 1974 ("TPA") and Fair Trading Acts ("FTA")

Nothing in this agreement is intended to have the effect of contracting out of any applicable provisions of the TPA or the FTA in each of the States and Territories of Australia, except to the extent permitted by those Acts where applicable

- Any instructions received by the Seller from the Customer for the supply of Goods and/or the Customer's acceptance of Goods supplied by the Seller shall constitute acceptance of the terms and conditions contained
- re more than one Customer has entered into this agreement, the Customers shall be jointly and severally liable
- Where more than one Customer has entered into this agreement, the Customers shall be jointly and severally liable for all payments of the Price.

 Upon acceptance of these terms and conditions by the Customer the terms and conditions are binding and can only be amended with the written consent of the Seller.

 The Customer shall give the Seller not less than fourteen (14) days prior written notice of any proposed change of ownership of the Customer or any change in the Customer's name and/or any other change in the Customer's details (including but not limited to, changes in the Customer's address, facsimile number, or business practice). The Customer shall be liable for any loss incurred by the Seller as a result of the Customer's failure to comply with this chairs. this clause
- Goods are supplied by the Seller only on the terms and conditions of trade herein to the exclusion of anything to the contrary in the terms of the Customer's order notwithstanding that any such order is placed on terms that purport to override these terms and conditions of trade.
- These terms and conditions are meant to be read in conjunction with the Seller's Security System Agreement (where applicable). If there are any inconsistencies between the two documents then the terms and conditions 3.6 contained in this document shall prevail.

Price And Payment

- Price And Payment
 At the Seller's sole discretion the Price shall be either:
 (a) as indicated on invoices provided by the Seller to the Customer in respect of Goods supplied; or
 (b) the Seller's quoted Price (subject to clause 4.2) which shall be binding upon the Seller provided that the Customer shall accept the Seller's quotation in writing within thirty (30) days.
 The Seller reserves the right to change the Price in the event of a variation to the Seller's quotation.
 At the Seller may submit a detailed payment claim at intervals not less than one month for work performed up to the end of each month. The value of work so performed shall include the reasonable value of authorised variations, whether or not the value of such variations has been finally agreed between the parties, and the value of materials delivered to the site but not installed.
 At the Seller's sole discretion payment shall be due before delivery of the Services.
- At the Seller's sole discretion payment for approved Customers shall be made by instalments in accordance with the Seller's payment schedule.
- Time for payment for the Goods shall be of the essence and will be stated on the invoice or any other forms. If no time is stated then payment shall be due fourteen (14) days following the date of the invoice. 4.7
- Payment will be made by cash, or by cheque, or by bank cheque, or by credit card Visa and Mastercard only (plus a surcharge of up to three percent (3%) of the Price), or by direct credit, or by any other method as agreed to between the Customer and the Seller. 4.8
- 4.9. GST and other taxes and duties that may be applicable shall be added to the Price except when they are expressly included in the Price

- **Delivery Of Goods**At the Seller's sole discretion delivery of the Goods shall take place when:

- At the Seller's sole discretion delivery of the Goods shall take place when:

 (a) the Customer takes possession of the Goods at the Seller's address; or

 (b) the Customer takes possession of the Goods at the Customer's nominated address (in the event that the
 Goods are delivered by the Seller or the Seller's nominated carrier).

 At the Seller's sole discretion the costs of delivery are:

 (a) included in the Price; or

 (b) in addition to the Price; or

 (c) for the Customer's account.

 The Customer shall make all arrangements necessary to take delivery of the Goods whenever they are tendered

 for delivery, the event that the Customer is unable to take delivery of the Goods as arranged then the Seller shall for delivery. In the event that the Customer is unable to take delivery of the Goods as arranged then the Seller shall be entitled to charge a reasonable fee for redelivery.

 Belivery of the Goods to a third party nominated by the Customer is deemed to be delivery to the Customer for the

- purposes of this agreement. The failure of the Seller to deliver shall not entitle either party to treat this contract as repudiated.
- The Seller shall not be liable for any loss or damage whatever due to failure by the Seller to deliver the Goods (or any of them) promptly or at all, where due to circumstances beyond the control of the Seller.

- If the Seller retains ownership of the Goods nonetheless, all risk for the Goods passes to the Customer on delivery. If any of the Goods are damaged or destroyed following delivery but prior to ownership passing to the Customer, the Seller is entitled to receive all insurance proceeds payable for the Goods. The production of these terms and conditions by the Seller is sufficient evidence of the Seller's rights to receive the insurance proceeds without the need for any person dealing with the Seller to make further enquiries

- Title
 The Seller and Customer agree that ownership of the Goods shall not pass until:
 (a) the Customer has paid the Seller all amounts owing for the particular Goods; and
 (b) the Customer has met all other obligations due by the Customer to the Seller in respect of all contracts between
 the Seller and the Customer.

 Receipt by the Seller of any form of payment other than cash shall not be deemed to be payment until that form of
- payment has been honoured, cleared or recognised and until then the Seller's ownership or rights in respect of the Goods shall continue
- It is further agreed that:
 - (a) where practicable the Goods shall be kept separate and identifiable until the Seller shall have received payment and all other obligations of the Customer are met; and
 - (b) until such time as ownership of the Goods shall pass from the Seller to the Customer the Seller may give notice in writing to the Customer to return the Goods or any of them to the Seller. Upon such notice the rights of the Customer to obtain ownership or any other interest in the Goods shall cease; and

 - Customer to obtain ownership or any other interest in the Goods shall cease; and

 (c) the Selier shall have the right of stopping the Goods in transit whether or not delivery has been made; and

 (d) if the Customer falls to return the Goods to the Selier then the Selier or the Selier's agent may enter upon and

 into land and premises owned, occupied or used by the Customer, or any premises as the invitee of the

 Customer, where the Goods are situated and take possession of the Goods; and

 (e) the Customer is only a ballee of the Goods and until such time as the Seller has received payment in full for the

 Goods then the Customer shall hold any proceeds from the sale or disposal of the Goods, up to and including

 the amount the Customer owes to the Seller for the Goods, on trust for the Seller; and

 (f) the Customer shall not charge the Goods in any way nor grant nor otherwise give any interest in the Goods

 while they remain the property of the Seller; and

 (h) the Seller can issue proceedings to recover the Price of the Goods sold notwithstanding that ownership of the

 Goods may not have passed to the Customer; and

 (i) until such time that ownership in the Goods passes to the Customer, if the Goods are converted into other

 products, the parties agree that the Seller will be the owner of the end products.

- The Customer shall inspect the Goods on delivery and shall within five (5) days of delivery (time being of the essence) notify the Seller of any alleged defect, shortage in quantity, damage or failure to comply with the description or quote. The Customer shall afford the Seller an opportunity to inspect the Goods within a reasonable description or quote. The Customer shall afford the Seller an opportunity to inspect the Goods within a reasonable time following delivery if the Customer believes the Goods are defective in any way. If the Customer shall fail to comply with these provisions the Goods shall be presumed to be free from any defect or damage. For defective Goods, which the Seller has agreed in writing that the Customer is entitled to reject, the Seller's liability is limited to either (at the Seller's discretion) replacing the Goods or repairing the Goods except where the Customer has acquired Goods as a consumer within the meaning of the Trade Practices Act 1974 (CWIth) or the Fair Trading Acts of the relevant state or territories of Australia, and is therefore also entitled to, at the consumer's discretion either a refund of the purchase price of the Goods, or repair of the Goods, or replacement of the Goods. Goods will not be accepted for return other than in accordance with 8.1 above.

Warranty
Subject to the conditions of warranty set out in clause 9.2 the Seller warrants that if any defect in any workmanship
of the Seller becomes apparent and is reported to the Seller within twelve (12) months of the date of delivery (time
being of the essence) then the Seller will either (at the Seller's sole discretion) replace or remedy the workmanship.
The conditions applicable to the warranty given by clause 9.1 are:

- (a) the warranty shall not cover any defect or damage which may be caused or partly caused by or arise through:

 (i) failure on the part of the Customer to properly maintain any Goods; or

 (ii) failure on the part of the Customer to follow any instructions or guidelines provided by the Seller; or

 (iii) any use of any Goods otherwise than for any application specified on a quote or order form; or

 (iv) the continued use of any Goods after any defect becomes apparent or would have become apparent to a
 reasonably prudent operator or user; or

 (v) fair wear and tear, any accident or act of God.

 (b) the warranty shall cease and the Seller shall thereafter in no circumstances be liable under the terms of the
 warranty if the workmanship is repaired, aftered or overhauled without the Seller's consent.

 (c) in respect of all claims the Seller shall not be liable to compensate the Customer for any delay in either
 replacing or remedying the workmanship or in properly assessing the Customer's claim.

 For Goods not manufactured by the Seller, the warranty shall be the current warranty provided by the manufacturer of the Goods. The Seller shall not be bound by nor be responsible for any term, condition, representation or warranty other than that which is given by the manufacturer of the Goods.

 Where the Seller has designed, drawn or written Goods for the Customer, then the copyright in those designs and drawings and documents shall remain vested in the Seller, and shall only be used by the Customer at the Seller's

The Customer warrants that all designs or instructions to the Seller will not cause the Seller to infringe any patent, registered design or trademark in the execution of the Customer's order and the Customer agrees to inde Seller against any action taken by a third party against the Seller in respect of any such infringement.

- Default & Consequences of Default
 Interest on overdue invoices shall accrue daily from the date when payment becomes due, until the date of payment, at a rate of two and one half percent (2.5%) per calendar month and such interest shall compound monthly at such a rate after as well as before any judgment.

 If the Customer defaults in payment of any invoice when due, the Customer shall indemnify the Seller from and against all costs and disbursements incurred by the Seller in pursuing the debt including legal costs on a solicitor and own client basis and the Seller's collection agency costs.

 Without prejudice to any other remedies the Seller may have, if at any time the Customer is in breach of any obligation (including those relating to payment), the Seller may have, or the suppend or terminate the supply of Goods to the Customer and any of its other obligations under the terms and conditions. The Seller will not be liable to the Customer for any loss or damage the Customer suffers because the Seller has exercised its rights under this clause. clause.
- If any account remains overdue after thirty (30) days then an amount of the greater of twenty dollars (\$20.00) or ten

- Security And Charge
 Despite anything to the contrary contained herein or any other rights which the Seller may have howsoever:
 (a) where the Customer and/or the Guarantor (if any) is the owner of land, realty or any other asset capable of being charged, both the Customer and/or the Guarantor agree to mortgage and/or charge all of their joint and/or several interest in the said land, realty or any other asset to the Seller or the Seller's nominee to secure all amounts and other monetary obligations payable under these terms and conditions. The Customer and/or the Guarantor acknowledge and agree that the Seller (or the Seller's nominee) shall be entitled to lodge where appropriate a caveat, which caveat shall be withdrawn once all payments and other monetary obligations payable hereunder have been met
 - , should the Seller elect to proceed in any manner in accordance with this clause and/or its sub-clauses, the Customer and/or Guarantor shall indemnify the Seller from and against all the Seller's costs and disbursements including legal costs on a solicitor and own client basis.
 - (c) the Customer and/or the Guarantor (if any) agree to irrevocably nominate constitute and appoint the Seller or the Seller's nominee as the Customer's and/or Guarantor's true and lawful attorney to perform all necessary acts to give effect to the provisions of this clause 12.1.

- Cancellation
 The Seller may cancel any contract to which these terms and conditions apply or cancel delivery of Goods at any time before the Goods are delivered by giving written notice to the Customer. On giving such notice the Seller shall repay to the Customer any sums paid in respect of the Price. The Seller shall not be liable for any loss or damage whatever arising from such cancellation.

 In the event that the Customer cancels delivery of Goods the Customer shall be liable for any loss incurred by the Seller (including, but not limited to, any loss of profits) up to the time of cancellation.

 (b) the right to retain the item for the Price while the Seller is in possession of the item;
